Michael Botticelli Becomes ONDCP Deputy Director

Michael Botticelli was sworn in as ONDCP Deputy Director on November 27, 2012. Mr. Botticelli has more than 20 years of experience in the treatment and recovery field, including service as Director of the Massachusetts Bureau of Substance Abuse Services. He has served in leadership roles for the National Association of State Alcohol and Drug Abuse Directors and was a member of the Advisory Committee for the Substance Abuse and Mental Health Services Administration's Center for Substance Abuse Prevention as well as the National Action Alliance for Suicide Prevention. In 2008, he was the first recipient of the annual Ramstad/Kennedy National Award for Outstanding Leadership in Promoting Addiction Recovery and, in 2012, was awarded the National Association of State Alcohol and Drug Abuse Directors' Service Award. Mr. Botticelli is in longterm recovery from addiction, celebrating more than 24 years of sobriety.

18,000 Join Philadelphia Recovery Walk & Rally

Deputy Director of Demand Reduction Mineta helped lead the 2012 Recovery Walks! march in Philadelphia and addressed a spirited audience of 18,000 following the walk. He was accompanied by ONDCP Recovery Branch Chief Peter Gaumond, who was a member of the Honor Guard, a group of 340 individuals with 10 years or more of recovery. Honor Guard members had a combined total of 6,493 years of recovery. Other speakers included Arthur Evans, Commissioner of the Philadelphia Department of Behavioral Health and Developmental disAbilities, Pat Taylor of Faces & Voices of Recovery, and Gary Tennis, Secretary of the Pennsylvania Department of Drug and Alcohol Programs,

who reminded participants they were "a beacon of hope for the one out of four families that is still suffering." Ted Williams, a formerly homeless man now celebrated as "the Golden Voice," was the honored guest. Additionally, the final of the "Recovery Idol" competition, for which thousands auditioned, was held live and on stage. The highlight was a performance by Philadelphia Rhythm & Blues legend Bunny Sigler.

Research and Data

Study Seeks to Map Collegiate Recovery Assets Research supported by the Stacie Mathewson Foundation aims to identify and begin mapping campus, community, and program assets that are critical to successful collegiate recovery programs.

Asset models are widely used to describe factors that are associated with or contribute to positive adolescent development, developmental environments, and recovery

in general populations. This appears to be the first application of asset models to the collegiate recovery environment. Findings of the study, scheduled to be released in March 2013, have the potential to inform research, policy makers, practitioners, and others interested in the advancement of collegiate recovery programs. Eighteen months ago, Mary — a mother of four children age 6, 11, 13, and 15 — was facing DUI charges. She was under house arrest and required to wear an ankle bracelet that monitored her blood alcohol level hourly.

Today, Mary is a volunteer at a recovery community center, <u>Turning Point Center of Chittenden County</u>, a



certified victim and crisis worker, and a sponsor in her chosen mutual aid pathway. A talented photographer, she provided the image above depicting how her life has changed since she entered recovery.
